- All houses must be mounted on a wood board base. Please affix name of entrant to bottom of base. Edge of base may be decorated with ribbon or paint or other non-edible finish.
- Entry will remain on display from Thursday, December 1 through Sunday, December 4, 2016.
- I must pick up my entry not later than noon, Monday, December 5, 2016 or a mutually agreed to time on December 5 with host business owner. Entries not picked up on December 5 will be discarded, No Exceptions.
- Permission is hereby granted to Olde Mistick Village to print or otherwise duplicate the picture or likeness of my entry and/or me with my entry for either internal or external release this includes print and online publications.
